- 4) To reduce the risks, I agree to obey the rules of the range and follow instructions given by members of staff. I will ensure that all children under my care will follow the same rules and obey instructions given by members of staff.
- 5) I accept that I or all children under my care must wear safety equipment.
- 5) I accept that I am responsible for my own safety and behaviour, and that of any children that I have accepted responsibility for.
- 6) If I am supervising children I acknowledge that I am expected to assist the children in my care during the activities.
- 7) By signing this waiver, and to the best of my knowledge, I have declared myself, and/or the children in my care have no underlying health conditions or pre existing injuries which could inhibit my/their ability to participate in the programmes or activities provided .
- 8) In the event of an accident, loss, damage to property, injury to myself or children in my care, I agree to waive all claims against Prima Archery Ltd in respect of myself and the children in my care.
- 9) I am not under the adverse influence of alcohol or drugs.
- 10) I acknowledge, understand and accept the risks involved and am responsible for my own actions or involvement or that of any children under my care.
